

H2H RANCH VISIT & VOLUNTEER LIABILITY RELEASE FORM

In exchange for participation in the activity of visitation to H2H Ranch and in having contact with the H2H Ranch animals organized by H2H Ranch (Heart 2 Heart Ranch), of 26040 Pioneer Lane Parma, ID 83660 and/or of the property, facilities and services of H2H Ranch, I agree for myself and (if applicable), for the members of my family, group to the following:

_____ 1. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by H2H Ranch, owners, employees, representatives or agents of H2H Ranch.

_____ 2. I know, recognize and understand that animal behavior is inherently unpredictable and that there are certain inherent risks associated with the above described activity. I assume full responsibility for personal injury to myself and (if applicable), my family members, group and further release and discharge H2H Ranch for injury, loss or damage arising out of me or my family's use of or presence upon the facilities of H2H Ranch, whether caused by the fault of myself, my family, H2H Ranch or other third parties.

_____ 3. I agree to indemnify and defend H2H Ranch against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from me or my family's, group's use of or presence upon the facilities of H2H Ranch. I agree to pay for all damages to the facilities of H2H Ranch caused by me or my family's negligent, reckless, or willful actions.

_____ 4. I consent to the participation of my child(ren), _____

_____ and/or myself of _____ group, in visit to the H2H Ranch and contact with farm animals, riding mules/horses, and agree on behalf of the above minor to all of the terms and conditions of this agreement. By signing this Liability Release Form, I represent that I have legal authority over and consent of said child(ren).

_____ 5. In the event of an injury to the above minor during the above described activities, I give my permission to H2H Ranch, owners, or to the employees, representatives or agents of H2H Ranch to arrange for all necessary medical treatment for which I shall be financially responsible.

_____ 6. Furthermore, I understand that from time to time, photographs and videos may be taken at the H2H Ranch and that I may be in one or more photographs or videos. I do hereby give permission to H2H Ranch to publish and use such photographs and videos for any lawful purpose.

_____ 7. Any legal or equitable claim that may arise from participation in the above shall be resolved under Idaho State Law.

_____ 8. All, references to H2H Ranch includes its Owners: Jeff and Trinity Jackson, Board of Directors, Executive Director and Officers, agents, employees, independent contractors, instructors, physicians, therapists and any associated professionals and volunteers.
